
HARNESSING FOR ACHIEVING THE SUSTAINABI **DEVELOPMEN GOALS**

he year 2016 marked the third consecutive hottest on record per the National Oceanic and

Atmospheric Administration (NOAA) and National Aeronautics and Space Administration (NASA). The fifth Assessment Report of the Intergovernmental Panel on Climate Change (IPCC) concludes that the warming in the climate system is unequivocal. In the Conference of Parties (COP21), the Paris summit in Dec 2015 agreed to limit the rise in global temperature below 2°C above the pre-industrial level. here are many indexbased approaches intended to assess socio-

ecological vulnerability to natural hazards. Two such indices are the Global Deltas Risk Index (GDRI), created by UNU-EHS, and the Social Vulnerability Index (SoVI), introduced by Cutter et al. (2003) and a continued research focus at the Hazards and Vulnerability Research Institute (HVRI) at the University of South Carolina. As part of his Master's thesis at UNU-EHS, Carl is comparing these indices in the socialecological context of the Mississippi Delta, one of the most vulnerable regions in the US. Read More
